- b. Saturday, February 3, 2024 The Presbytery will be installing Pastor Don as our Designated Pastor. Ministers and Elders from other churches of the Presbytery will be participating in and leading this service of worship. Pastor Don has assembled a committee of Nancy Chee, Jackie Jew, Annie Wong, and Eleanor Wong to help with planning the reception.
- c. After 12 consecutive years of service, David Miller will be taking a sabbatical in 2024 from the Worship and Nurture committee and other areas of worship planning and production. We give thanks to God for David's spiritual gifts, talents, and faithful service as he completes his term of service as a ruling elder.

4. Board of Deacons

- a. Cookie Distribution On December 16th, the deacons helped organizer Nancy Chee pack 36 bags of homemade cookies and treats. The cookie bags were delivered by the Deacon team of elves to members of our community focusing on our super-seniors and those whose lives were touched in 2023 by death, surgery, illness, and other special circumstances.
- b. Christmas Gift to Food Pantry Clients The Deacons teamed with the Food Pantry and M&E to buy and distribute 260 bottles of oyster sauce to clients. As the gifts were handed out to clients, Shar Hall greeted them in Cantonese with "Merry Christmas and Happy New Year. This is a gift from the Presbyterian Church".

5. Pastor's Report

- a. Pastor Don will continue to serve on the Presbytery Committee on Ministry through 2026 and will be adding a new assignment on a special committee tasked with rewriting the standing rules of the Presbytery.
- b. He gave his final report as the Interim Pastor and closed his remarks by saying, I am excited (by) the possibilities that we will explore together. I am thankful to our God that we have so much new to explore. I am looking forward to our work together to be good stewards of what we have inherited here in PCC and to see how we can adapt.

New Business – A Message from the English Commission to the Worshiping Community

The English Commission continues to deliberate on the action taken by the Mandarin Commission as reported to the Session on September 10th and reiterated on December 10th. The ramifications of their decision have led to ongoing discussions by the English Commission that touched on the requirements of the PCC Bylaws, revelations from the Bible, guidance of the Book of Order, roles and responsibilities of ruling elders and teaching elders including commissioned lay pastors, and theology.

The issues are complex and highly sensitive and require the Commission to uphold confidentiality. Further, we understand the Community's need to be informed and desire to help. We offer the following summary and timeline of key developments from Session and Commission records and ask for your patience and prayers of guidance from the Holy Spirit.

<u>September 10</u> – PCC Session Meeting

The Mandarin Commission decided they will not participate in or attend any joint worship services where Pastor Don is officiating as a worship leader. They took this action because Pastor Hammond announced in a sermon on June 25 that he is bisexual and is currently dating a gay man. They based their vote on their understanding of Romans 1:18-32.

Because the Session had approved a trilingual worship for World Communion Sunday, October 1, the request by the Mandarin Commission for a separate communion service on October 1 needed to be approved by the Session. The motion was carried with two opposed.

October 1 – World Communion Sunday

81 members of the Cantonese and English communities joined together in person and online for worship, communion, and fellowship.

November 5 – 170th Anniversary of the PCC

The annual trilingual meetings of the congregation and corporation were held and followed by a time of fellowship.

November 14 - Presbytery of San Francisco Meeting

Rev. Don Hammond's call to serve as Designated Pastor for the English Worshiping Community of the Presbyterian Church in Chinatown effective January 1, 2024, was approved unanimously by the San Francisco Presbytery.

December 10 – PCC Session Meeting

The Session Moderator, Rev. Hammond, requested to re-open discussion in the Mandarin Commission about their decision not to participate in worship when Rev. Hammond is leading. The Mandarin Commission reiterated that their position had not changed.
