A Summary of the English Commission Meeting of September 2023

Committee and Other Reports

- 1. Mission and Evangelism
 - a. SRO School Supplies Project A total of \$2,430.90 was collected in donations and \$3,625.00 was spent to purchase 145 gift cards for SRO kids. The remaining cost was covered by the M&E budget.
 - b. S.F. Interfaith Council (SFIC) A walkathon is planned to raise funds for the Winter Interfaith Shelter program. The committee agreed to be an event sponsor at a cost of \$500.
 - c. Matthew 25 Summit: An Invitation to Innovation The Presbyterian Mission Agency will be hosting the inaugural conference on January 16-18, 2024, at the New Life Presbyterian Church in Atlanta. The committee will fund two \$199 scholarships to cover the registration fee for persons who wish to attend this gathering of mid-councils, congregations, and individuals to dialogue, learn, and grow with others through exploration of eradicating poverty, dismantling structural racism, and building congregational vitality.

2. Resource

Stewardship presentations during worship will begin on October 8 and conclude on December 3.

- 3. Worship & Nurture
 - a. Retreat Observations
 - 1) Participants enjoyed Rev. Veen's session that utilized movement inspired by scripture.
 - 2) Several people found the labyrinth walk meaningful; Pastor Don said that such a walk was created for people who are unable to make a pilgrimage to Jerusalem.
 - 3) More time and opportunities to pray were requested.
 - 4) Total cost for the retreat was \$6,500. About \$5,200 was received in registration fees leaving about \$1,300 to be funded by the W&N budget.
 - b. Presbyterian Women
 - The Presbyterian Women in the Presbytery of San Francisco are looking forward to their first in-person gathering on October 7th since the Covid pandemic prevented them from getting together.
 - 2) Planning for the 2024 Presbyterian Women Churchwide Gathering (CWG) in St. Louis is well under way with Jeanette Huie as CWG Chair and Linda Lee as CWG Plenary Work Group Chair.
 - c. Worship Attendance during August in person in parentheses

- 4. Treasurer's Report
 - a. Budget Notes
 - 1) \$100K was withdrawn from a low interest yielding Synod account and transferred to a certificate of deposit that yields 4.9% annually.
 - 2) Line item 301 United Mission Support (GA) Of the total amount budgeted, approximately 85% is distributed to San Francisco Presbytery, 11% to General Assembly and 3% to Synod.

To Do: Pastor Don will reach out to the Synod for information about how church contributions earmarked for the Synod are used. Marda Quon Stothers may be a resource to answer questions regarding use of funds by the presbytery.

New Business

- 1. Immigrant Accompaniment
 - a. Motion: To approve the Mission and Evangelism Committee's recommendation to go forward with participating with the Interfaith Movement for Human Integrity (IM4HI) Nueva Esperanza Accompaniment Teams program and forming a PCC English Worshiping Community accompaniment team.
 - b. Discussion

Questions were asked about the time and extent of this commitment. Will this first attempt at accompaniment be handled and evaluated as a pilot program or is the commitment ongoing? What have we learned from other congregations' experiences who formed accompaniment teams?

- c. Action: The motion was passed unanimously.
- d. To Do: Once the team is launched, M&E will give monthly reports about accompaniment to the Commission as they do with other programs such as the food pantry.
